

How to Reserve a Business Name and Start a business registration online.

Things you will need:

- 1. A device with access to the internet
- 2. An approved reserved name
 - i. To get an approved reserved name just follow Steps (1 and 4 7).
- 3. Proof of address
 - i. This is any recent document used to verify your current address. These documents may include (e.g. Utility Bill or Driver's License). If a utility bill is used, they should not be older than three (3) months.
 - ii. Any proof of address document used needs to be in a digital form so than it can be attached to the registration. Accepted digital copies include pdf versions of the utility bills or an image of satisfactory quality depicting CLEARLY the person's name and their address.
- 4. Identification (Driver's License, Passport or Voters Id)
 - Any identification document used needs to be in a digital form so than it can be attached to the registration. Accepted digital copies include pdf versions of the identification used or an image of satisfactory quality depicting CLEARLY the person's name, their image, the issuing country and identification number.

Step 1. Sign-In / Sign-Up

Navigate to https://services.orcjamaica.com/fp/home

If you have a username and password for the Companies Office of Jamaica website the enter them and click sign-in. If you are new to the site, then click Create Account, fill out the fields on the form, and click Register
